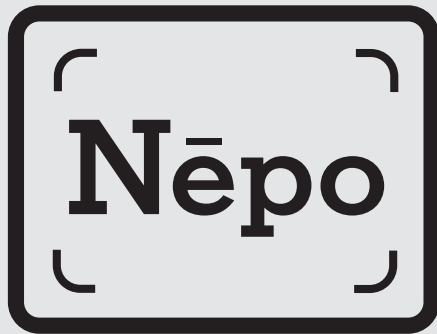

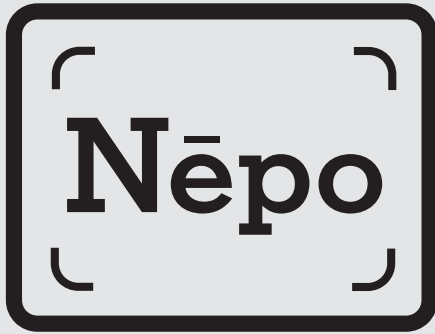

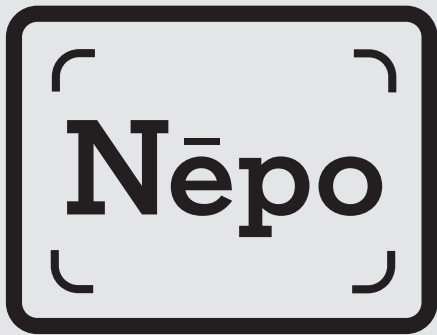

Frequently Asked Questions

## ***Why should I consider having my wedding videographed?***

There are many reasons to consider videography as the primary record of your wedding. In a recent national survey of brides conducted by WEVA the number one reason reported was: "To have a complete recorded history of the sights and sounds of my wedding day to show to my children and grandchildren someday." With today's DVDs estimated to last 100 years, the sights and sounds of your day can be cherished by many generations.

Many of our clients also mention the quality and convenience of modern videography. Almost all of us enjoy watching programs such as TLC's "A Wedding Story" and we are offering services of a similar quality and style at surprisingly affordable costs.

In summary, the primary reasons for professional wedding videography are: 1) To capture a lasting record of all the sights and sounds of your wedding day, 2) that is entertaining, and 3) convenient to keep and share.

## ***Does Nepo Productions LLC do all its own wedding videography, or is it ever "subcontracted"***

To assure quality we do all wedding videography and production ourselves.

## ***Will the DVD of my wedding play in my DVD player?***

Yes, and we guarantee it! We are able to work with multiple DVD formats to assure that our DVD's will play in your equipment. If for any reason we fail to deliver a DVD that will play in your player, we will provide you a new DVD player.

## ***Will the label ever come off the DVD or jam or damage my DVD player?***

No. We do not use labels. The DVD art work for your wedding is printed directly on to the DVD.

## ***Will the video of my wedding look professional?***

Yes. We continually enhance our skills, knowledge and equipment. Many pieces of our equipment inventory are used today by major documentary and movie production teams. We work hard to make a video you will be proud to share.

There is a difference though in live weddings, as opposed to movie and other entertainment productions. Your wedding party members are not selected according to script, your wedding is not staged and rehearsed, with many possible retakes. There are no stages with glaring lights and movable partitions like Hollywood. Just real people, real places. Your wedding is a real story based upon love and family. To us though, this only makes your wedding a more real and loving story to capture, then be shared forever. Our skills and equipment are honed to capture your story the way you want it. We can share with you our past videos and listen to your hopes and then tailor a package to meet your vision.

## ***Are you willing to use photos and video taken by family and friends?***

Yes! We invite additional photos and video footage taken by friends and family. The photos and tapes will of course be returned to you.
